Such litigation and administrative matters have included claims for: (i) discrimination based upon age, race, national origin, disability, gender and religion; (ii) sexual harassment (same sex and opposite sex) and other hostile work environment claims; (iii) ADA claims; (iv) FMLA retaliation claims; (v) whistleblower claims; (vi) ADEA claims; (vii) violations of drug testing policies and Minnesota's drug testing act; (viii) wage claims; (ix) violations of non-compete agreements; (x) violations of the trade secrets act; (xi) unfair competition; (xii) breach of fiduciary duty and the duty of loyalty; and (xiii) minority shareholder claims. In addition to litigation, Shannon advises and provides training on proper hiring and firing procedures and human rights issues. She has also served as a speaker on behalf of various organizations regarding employment-related topics.

Shannon was recognized early on as one of Minnesota's "Rising Stars" in the legal profession from 1999 to 2002, and she has been named a "Super Lawyer" every year since 2003. In addition, she was named one of the Top 100 Minnesota Super Lawyers by *Minnesota Law & Politics* in 2009.
